General Description

The TYCO Series TY-FRL, 2.8, 5.6, and 8.0 K-factor, Upright and Pendent Sprinklers described in this data sheet are quick response, standard coverage, solder type spray sprinklers designed for use in light and ordinary hazard commercial occupancies such as banks, hotels, shopping malls, schools, and hospitals.

The recessed version of the 2.8 and 5.6 K-factor, Series TY-FRL Pendent Sprinkler, where applicable, is intended for use in areas with a finished ceiling. It uses a two-piece Style 20 (1/2 in. NPT) Recessed Escutcheon. The recessed escutcheon provides 1/4 in. (6,4 mm) of recessed adjustment or up to 1/2 in. (12,7 mm) of total adjustment from the flush pendent position. The adjustment provided by the recessed escutcheon reduces the accuracy to which the fixed pipe drops to the sprinklers must be cut.

An intermediate level version of the 5.6 and 8.0 K-factor, Series TY-FRL Pendent Sprinkler can be obtained by utilizing the Series TY-FRL Pendent Sprinkler in combination with the Model S4 Shield.

Operation

The fusible link (heat collector) assembly is comprised of two halves that are joined together by a thin layer of solder. When the rated temperature is reached, the solder melts and the two link halves separate, allowing the sprinkler to operate.

Design Criteria

The TYCO Series TY-FRL Pendant and Upright Sprinklers are intended for fire protection systems designed in accordance with the standard installation rules recognized by the applicable Listing or Approval agency - for example, the UL Listing is based on the requirements of NFPA 13, and FM Approval is based on the requirements of FM's Loss Prevention Data Sheets. Only the style 20 recessed escutcheon, as applicable, is to be used for recessed pendent installations.

Installation

The TYCO Series TY-FRL Sprinklers must be installed in accordance with this section.

A leak tight 1/2 in. NPT sprinkler joint should be obtained with a torque of 7 ft-lb to 14 ft-lb (9,5 N·m to 19,0 N·m). A leak tight 3/4 in. NPT sprinkler joint should be obtained with a torque of 10 ft-lb to 20 ft-lb (13,4 N·m to 26,8 N·m). Higher levels of torque may distort the sprinkler inlet and cause leakage or impairment of the sprinkler.

Do not attempt to make-up for insufficient adjustment in the escutcheon plate by under- or over-tightening the sprinkler. Readjust the position of the sprinkler fitting to suit.

Series TY-FRL Pendant and Upright Sprinkler Installation

The Series TY-FRL Pendant and Upright Sprinklers must be installed in accordance with this section.

Step 1. Pendent sprinklers are to be installed in the pendent position, and upright sprinklers are to be installed in the upright position.

Step 2. With pipe thread sealant applied to the pipe threads, hand tighten the sprinkler into the sprinkler fitting.

Step 3. Tighten the sprinkler into the sprinkler fitting using only the W-Type 9 Sprinkler Wrench as shown in Figure 6. Apply the wrench to the wrench area as shown in Figures 1, 2, and 3.

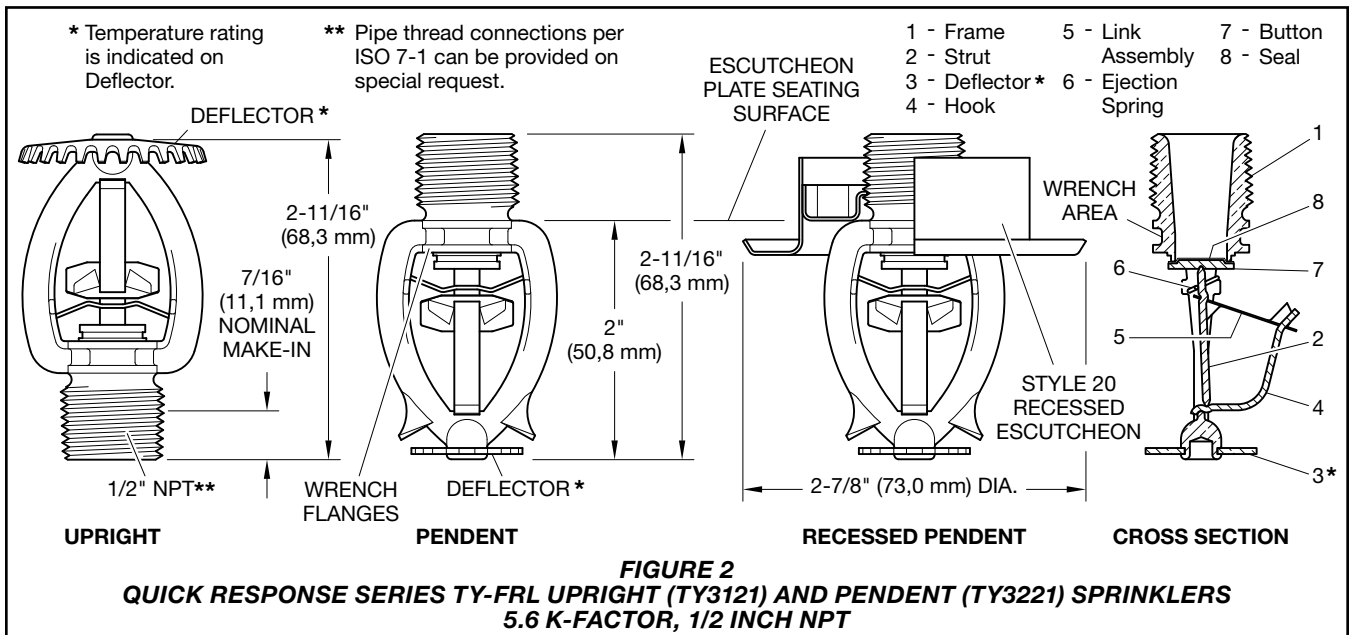
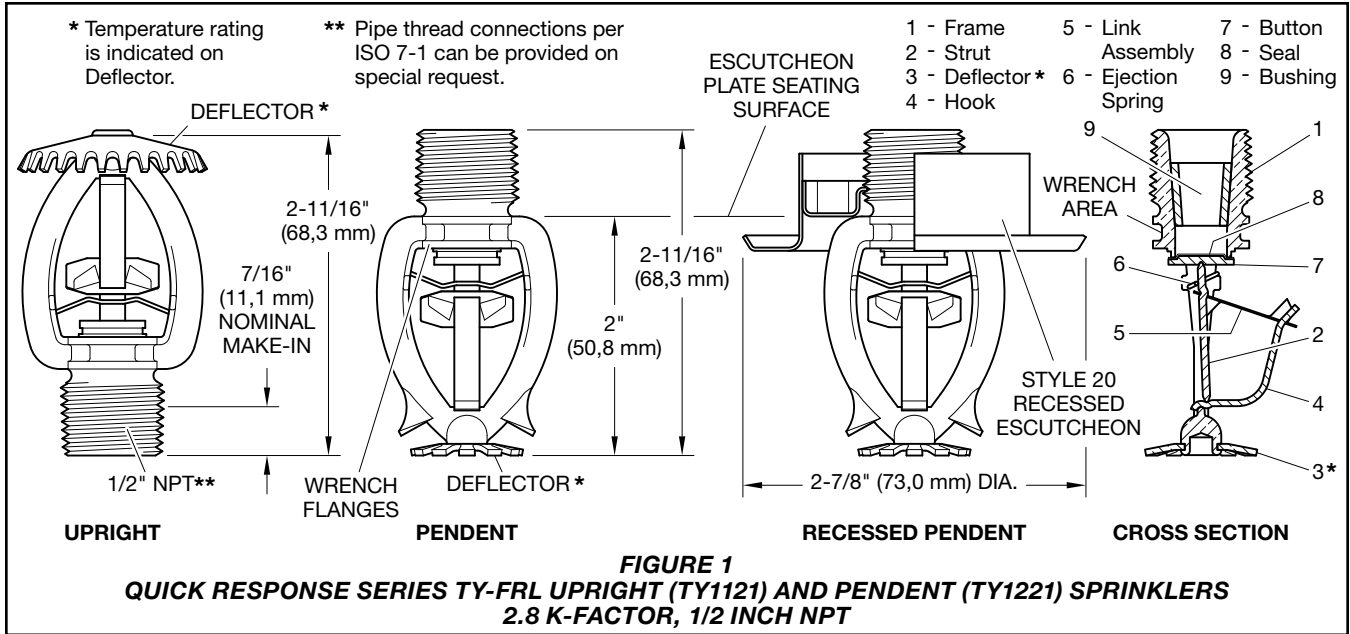
Series TY-FRL Recessed Pendent Sprinkler Installation

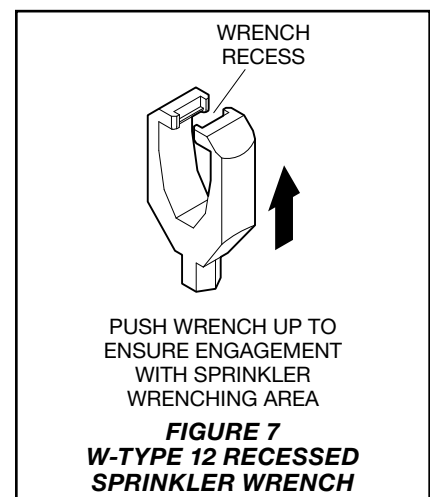
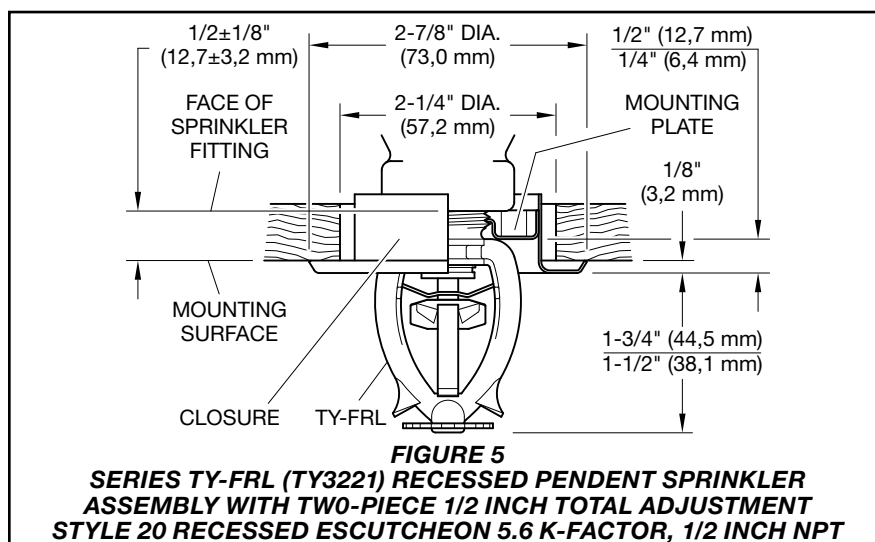
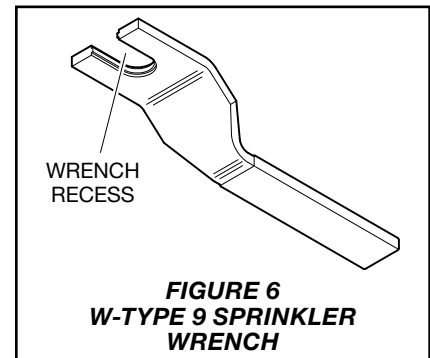
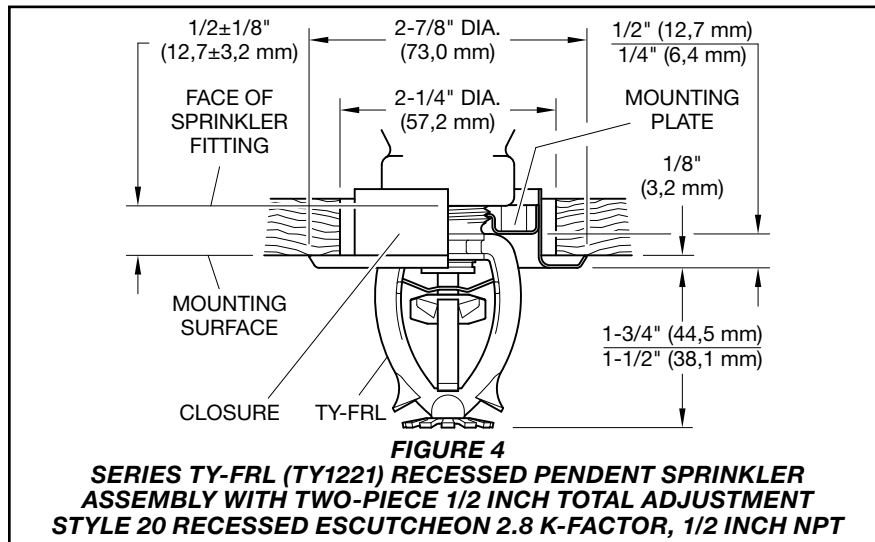
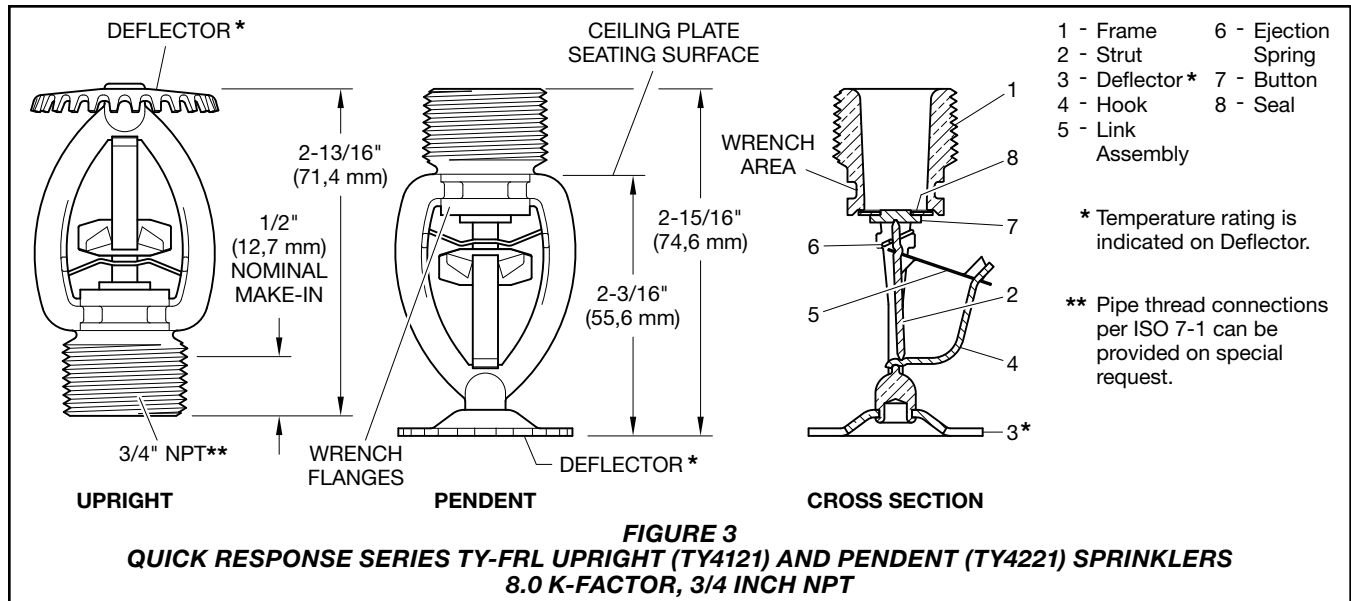
The Series TY-FRL Recessed Pendent Sprinklers must be installed in accordance with the following instructions.

Step A. After installing the style 20 mounting plate, as applicable, over the sprinkler threads and with pipe thread sealant applied to the pipe threads, hand tighten the sprinkler into the sprinkler fitting.

Step B. Tighten the sprinkler into the sprinkler fitting using only the W-Type 12 Recessed Sprinkler Wrench as shown in Figure 7. Apply the wrench to the sprinkler wrenching flanges as shown in Figures 1 and 2.

Step C. After the ceiling has been installed or the finish coat has been applied, slide on the style 20 escutcheon over the Series TY-FRL Sprinkler and push the escutcheon over the mounting plate until its flange comes in contact with the ceiling.

Care and Maintenance

The TYCO Series TY-FRL Sprinklers must be maintained and serviced in accordance with this section.

Before closing a fire protection system main control valve for maintenance work on the fire protection system that it controls, permission to shut down the affected fire protection system must be obtained from the proper authorities and all personnel who may be affected by this action must be notified.

Absence of an escutcheon, which is used to cover a clearance hole, may delay the time to sprinkler operation in a fire situation.

Sprinklers that are found to be leaking or exhibiting visible signs of corrosion must be replaced.

Automatic sprinklers must never be painted, plated, coated or otherwise altered after leaving the factory. Modified or over-heated sprinklers must be replaced.

Care must be exercised to avoid damage to the sprinklers -before, during, and after installation. Sprinklers damaged by dropping, striking, wrench twist/slippage, or the like, must be replaced.

The owner is responsible for the inspection, testing, and maintenance of their fire protection system and devices in compliance with this document, as well as with the applicable standards of the National Fire Protection Association such as NFPA 25, in addition to the standards of any other authorities having jurisdiction. Contact the installing contractor or product manufacturer with any questions.

It is recommended that automatic sprinkler systems be inspected, tested, and maintained by a qualified Inspection Service in accordance with local requirements and/or national codes.
